SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

: Do not breathe gas.

Avoid release of product into work area.

The product must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure. Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt.

Avoid suck back of water, acid and alkalis.

Containers, which contain or have contained flammable or explosive substances, must not be inerted with liquid carbon dioxide. Potential production of solid CO2 particles must be ruled out. In order to rule out potential electrostatic discharge production, the system must be adequately grounded.

Be aware of the risk of formation of static electricity with the use of CO2 extinguishers. Do not use them in places where a flammable atmosphere may be present.

Protect containers from physical damage; do not drag, roll, slide or drop.

Refer to supplier's container handling instructions.

Do not allow backfeed into the container.

When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders.

Leave valve protection caps in place until the container has been secured against either a wall or bench or placed in a container stand and is ready for use.

If user experiences any difficulty operating valve discontinue use and contact supplier.

Never attempt to repair or modify container valves or safety relief devices.

Damaged valves should be reported immediately to the supplier.

Keep container valve outlets clean and free from contaminants particularly oil and water. Replace valve outlet caps or plugs and container caps where supplied as soon as container is disconnected from equipment.

Close container valve after each use and when empty, even if still connected to equipment.

Never attempt to transfer gases from one cylinder/container to another.

Never use direct flame or electrical heating devices to raise the pressure of a container. Do not remove or deface labels provided by the supplier for the identification of the content of the container.

Suck back of water into the container must be prevented.

Open valve slowly to avoid pressure shock.
